Photographing and filming in the production areas of the companies is prohibited.



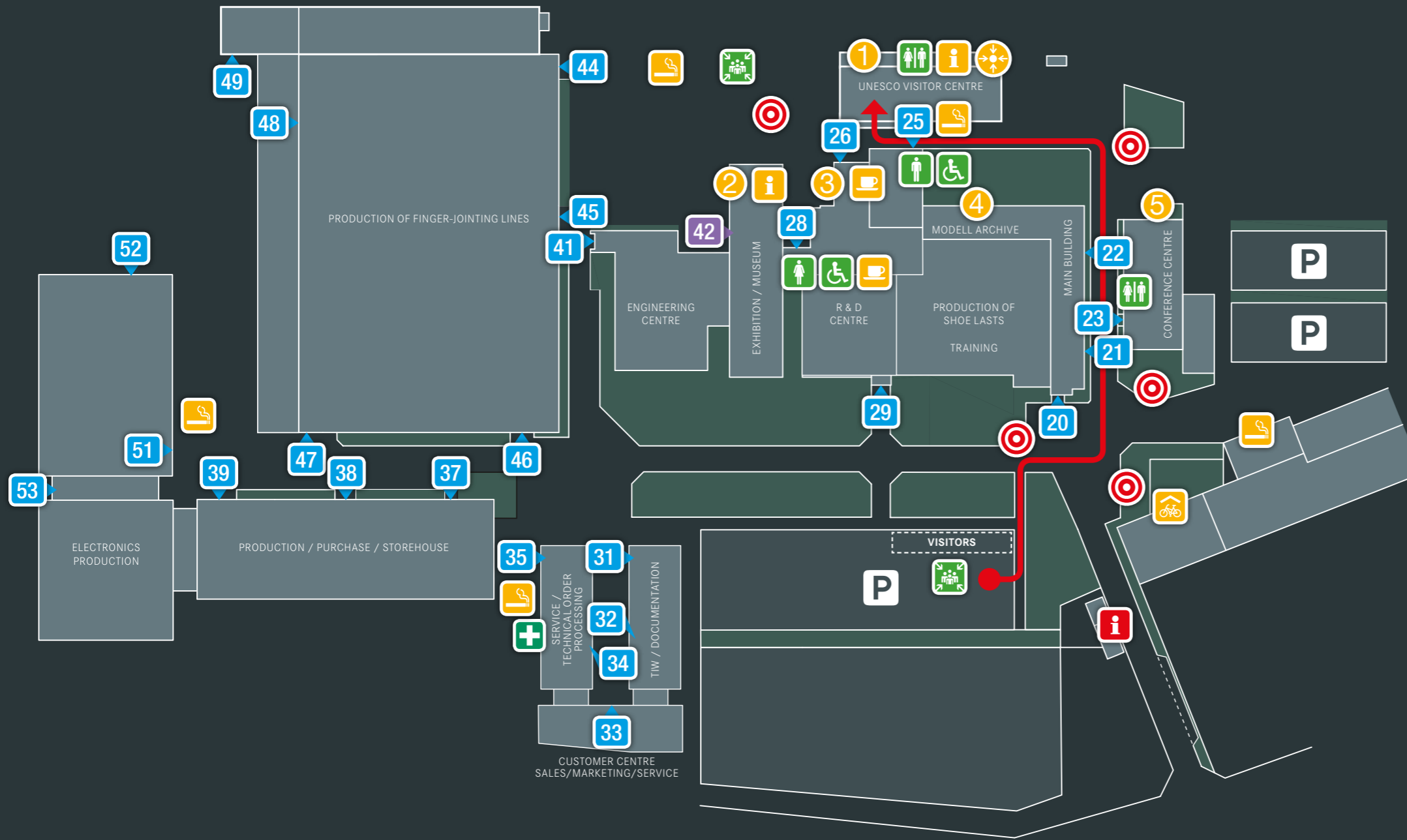
Please respect the ban on smoking within buildings. Please smoke only in the marked smoking areas and use the ashtrays.
